- Implementing and coordinating parent programs that build ties between families and the school, and
- Focusing on ways to increase parent involvement as a part of our Professional Learning Communities discussions.

**Antelope will coordinate with Head Start, other preschool programs, and parent resource centers to involve parents in the education of their children by:**

- Providing information to parents in and around the Antelope Community,
- Organizing a Kindergarten Round-Up to identify children of Kindergarten age, and
- Making parents aware of the resources available in close proximity to our school – Parent Information Resource Center (PIRC), Health Clinic, On-site Immunization and Flu Clinics.

- Posting translated documents on the school website, and
- Making Interpreters available.
